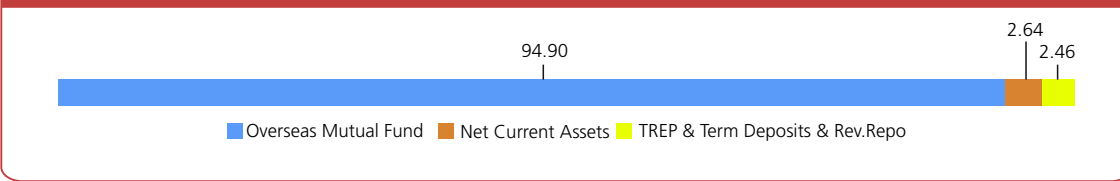

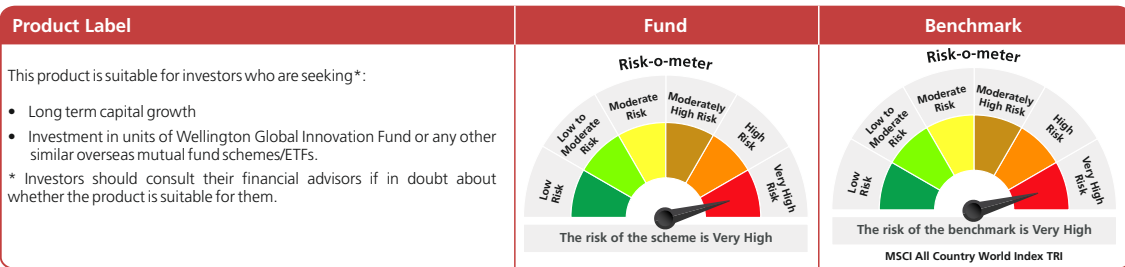
SECTOR ALLOCATION (%)
