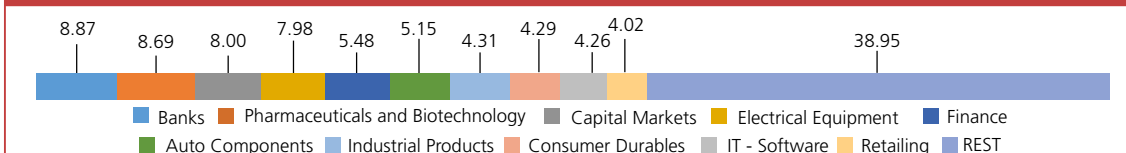

## SECTOR ALLOCATION (%)



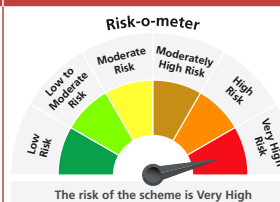

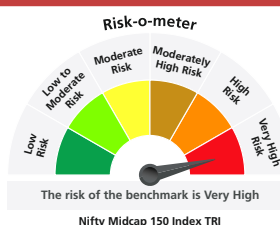
