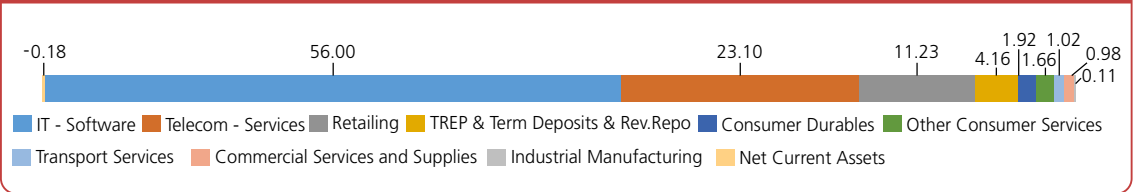

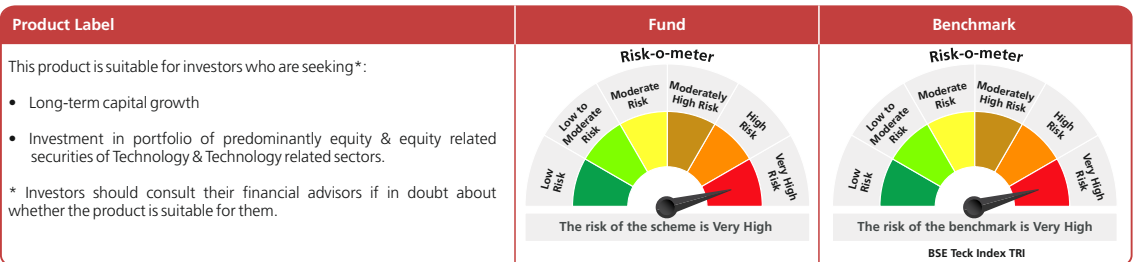
## SECTOR ALLOCATION (%)
