Sector & stock selection is an outcome of the research process, however

- Sector caps may be different for diversified and thematic funds; caps also on sector over-weights/under-weights; higher limits need specific approval
- Each fund limits exposure to each market cap viz. large cap, mid cap & small cap
- Liquidity of the portfolio should be within pre-defined limits



All funds* cap exposure to equity related instruments of a company to **10% of assets**



All regulatory limits, restrictions and guidelines wherever applicable are strictly hard-coded and adhered to



Portfolio optimization meetings help **to optimize risk adjusted return**
